### **DECISION TITLE: Dog Section Decision Paper**

#### **Executive Summary:**

This paper gives a recommendation to proceed with the programme of refurbishment and improvement to the headquarters dog section building.

The Police Exec board and Commissioner approved the disposal of the Wreay site and capital investment of £250K in the headquarters dog section building in November 2024.

A procurement exercise has been undertaken and the returned bids evaluated. Pinnington Ltd are the preferred bidder with a tender of £299,428.76. This the lowest bid and sets out a work programme of 11 weeks.

The total cost of the scheme with professional fees will be £320,000.00

#### **Recommendation:**

The commissioner is asked to:

- Approve an increase of £70K to fund the works to the dog section building.
- Appoint Pinnington Ltd to undertake the work.
