# **DECISION TITLE: Hunter Lane Decision Paper**

# **Executive Summary:**

This paper gives a recommendation to proceed with the final phase of the refurbishment and improvement works to Hunter Lane police station.

The Police Exec Board and Commissioner approved capital investment of £200K in 2024. The final phase was split into two areas work. The first area of work on the ground floor was completed in December 2024 to a value of £79K.

A procurement exercise has been undertaken for the second and final area of work. Following evaluation Johnsons 1871 are the preferred bidder with a tender of £129,619.62. This is the lowest bid and sets out a work programme of 15 weeks. The total cost of scheme with professional fees and contingencies will be £150,000.00.

The cost of the final phase of work is £229,000. This requires an increase in the capital investment of £29K.

#### Recommendation:

The commissioner is asked to:

- Approve the additional £29K to fund the works to finalise the Hunter Lane police station refurbishment works.
- Appoint Johnsons 1871 to undertake the work.
