REQUEST FOR POLICE & CRIME COMMISSIONER DECISION - (N° 019 / 2018)

TITLE: Business Intelligence Analytics

Executive Summary: (Précis not more than 100 words)

The Constabulary has prepared a business case for investment in Business Intelligence Analytics. Provision was made in the 2018/19 capital budget for this project which is designed to provide improved management information across the Constabulary and facilitate future savings.

Compared to the original estimate the overall investment requirements and savings have been significantly reduced.

The overall requirement will be for a revenue investment of £155,674 for the first two years if the preferred options are approved. The project will break even during Year 3 and provide savings annually from 2020/21 onwards.

Recommendation:

The Commissioner is asked to:

- Approve the investment in a Business Analytics project designed to improve management information in the Constabulary in line with the attached business case.
- Provide additional revenue funding of £155k over the next two years for the project to be funded from transfer of exiting capital budget and that the surplus capital budget be returned to reserves.
