## REQUEST FOR POLICE & CRIME COMMISSIONER DECISION - (N° 021 / 2018)

**TITLE: Constabulary Workforce Planning** 

**Executive Summary:** (Précis not more than 100 words)

In light of the Commissioner's Policing Pledge, which supported the precept proposal for 2018-19, the Constabulary has provided a workforce planning update for officer and PCSOs.

The main highlight is that the Constabulary anticipates having recruited the additional 25 officers pledged and reaching the new establishment of 1,145 officers by the end of July. However, this earlier recruitment and other changes to the workforce plan are projected to cost an additional £600k compared with the budget, which has been reported through the budget monitoring process.

The accelerated recruitment in the early part of 2018/19 gives a workforce planning option to recruit up to 20 officers above the approved establishment during the remainder of the year. Given the uncertainty over the impact of the new Police Educational Qualification Framework to be introduced by the College of Policing in January 2017, recruitment of additional officers in advance of this date may be a prudent measure. However, this must be balanced against the financial implications which are forecast at a further £350k in 2018/19 and £540k in 2019/20.

In relation to PCSOs, numbers are expected to fall below establishment over the year, principally due to PCSOs joining officer ranks.

## **Recommendation:**

The Commissioner is asked to:

- Delay the decision on whether to recruit over the current establishment until the financial and PEQF positions are clearer at the September strategy meeting.
- Approve the September intake of officers as an interim measure, which will maintain the option to recruit to a higher establishment later in the year. Estimated cost £100k.
- Request that the Chief Constable provides a plan to return PCSO numbers to establishment by the end of the 2018/19 financial year for the strategy day.
