REQUEST FOR POLICE & CRIME COMMISSIONER DECISION - (N° 023 / 2018)

TITLE: Brathay Trust 'Be SAVY' Project

Executive Summary: (Précis not more than 100 words)

Brathay Trust were funded over 2-years (October 2015 to September 2017) by the Police and Crime Commissioner for Cumbria to develop and deliver a programme aimed at reducing the number of young people being sexually exploited and/or at risk of being sexually exploited.

A total of 36 young women were referred into the programme, 27 young women were included in the final evaluation. Of the 27 young women who engaged in the programme, 82% of young women reported they were more able to recognise a healthy relationship, whilst 88% felt they had a greater ability to sort out the problems they might face.

Following on from the 2-year pilot, a proposal will see a further 9 targeted prevention programmes over a 3-year period being delivered in different locations across Cumbria. The aim of the project is to reduce the number of young people at risk of being sexually exploited in Cumbria and to improve the outcomes for those already being exploited. Children who are being sexually exploited often don't know what is happening to them, and can see themselves as willing participants in loving relationships. The programme promotes and develops critical awareness which helps young people recognise what is happening to them and reduces the harm. By engaging in the programme they develop knowledge and skills to avoid similar situations in the future.

The programme has been developed through discussions with local agencies, including Cumbria Constabulary. All have identified a need for this type of project in Cumbria which is not currently being met by services which target more serious cases of CSE and less focussed on prevention.

Recommendation:

The Commissioner is asked to:


- Approve funding for a 3-year period from PCC commissioned services budget, amounting to a total commitment of £68,491.
- Year 1: October 2018 to September 2019 = £17,213
- Year 2: October 2019 to September 2020 = £24,364
- Year 3: October 2020 to September 2021 = £26,914

PART 1 – NON CONFIDENTIAL FACTS AND ADVICE TO THE PCC

1. Introduction & Background

The aim of the Be SAVY project is to reduce the number of young people being sexually exploited in Cumbria and to improve outcomes for those who are exploited. It will build on the work that Brathay Trust has been delivering in Barrow, Millom and Whitehaven.

The intended outcomes for young people taking part in the project is:-

- Increase their understanding of sexual exploitation and grooming techniques
- Improve their trust of, and build positive relationships with, statutory and community services
- Increase the speed at which young people recognise they're being exploited and disclose what is happening to them, thereby increasing early intervention.

The project will provide a safe place and promote healthy relationships and secure attachments; providing a positive alternative to exploitation and giving the young people who engage in the programme a sense of control over their own lives and the choices they make.

The proposal is to run 9 targeted intervention programmes over 3 years in different locations across Cumbria. The locations of the programmes will be based on need and directed through information provided by police and other partners including LCSBs CSE working group who will identify and refer young people to cohorts.

The programme will work with 50 young people aged between 12 and 17 years over a three-year period, providing early help for children who are vulnerable and engaged in risky behaviour but don't currently qualify for intervention.

1.1 What will be the impact:-

The project will prevent vulnerable young people being sexually exploited and take pressure off services by reducing the number of young people needing statutory interventions.

Key Outcomes include:-

- Long-term reduction in the number of young people being or at risk of sexual exploitation.
- Participants will have increased understanding of sexual exploitation and grooming techniques.
- Participants will have improved trust of, and positive relationships with, statutory and community services.
- Participants will increase the speed at which they recognise they're being exploited and disclose what's happening to them so that agencies can intervene as quickly as possible.

1.2 Project Timescale:-

- Year one October 2018 to September 2019 cohort one, two and three
- Year two October 2019 to September 2020 cohort four, five and six
- Year three October 2020 to September 2021 cohort seven, eight and nine
