Introduction

Safer Cumbria is a partnership by which organisations work collaboratively to deliver a co-ordinated approach to Criminal Justice, Community Safety and Counter Terrorism across Cumbria. This innovative approach provides strategic direction and ensures the most effective use of resources.


Safer Cumbria provides a platform for these organisations to come together to determine how it will meet national requirements and to develop local priorities that will ensure the wellbeing and safety of communities and individuals across the county. This partnership also provides a mechanism to explore joint commissioning opportunities to deliver efficiency savings across organisations while maximising service delivery.

This plan outlines the key priorities the Safer Cumbria Partnership will focus on over the period identified. This will be reviewed annually to ensure new and emerging themes and issues are considered.

In line with legislative requirements a county Crime & Community Safety Agreement has been produced and is available at Appendix A of this plan. This agreement outlines how the Safer Cumbria Partnership will work together to deliver this.

Recognising that individual agencies will have their own dedicated areas of work and while this information can be shared with the Board Partners, the aim of the Safer Cumbria Partnership is to address those issues which can be best achieved and delivered most effectively by a Partnership approach and at a countywide level.


The Partnership will not work in isolation but will have strong interdependencies with the other key strategic boards in the county, namely:

- Cumbria Safeguarding Adults Board
- Cumbria Safeguarding Children Partnership
- The Children's Trust Board
- The Health & Wellbeing Board
- Cumbria Local Enterprise Partnership

The aims of The Three Key Functions

The Safer Cumbria Partnership will fulfil the function of the Local Criminal Justice Board (LCJB) for Cumbria. LCJBs were established as a means of developing and sustaining the close and effective partnership working across the CJS.

Criminal Justice



The Safer Cumbria Partnership will direct a countywide approach to community safety and will work closely with the three District Community Safety Partnerships to deliver the county approach at a local level.

Community Safety



The aim of the Counter Terrorism Strategy (CONTEST) is to reduce the risk to the UK and its interests overseas from terrorism.

The key objectives of the strategy are to:



PURSUE

to stop terrorist attacks



PREVENT

to stop people becoming terrorists or supporting terrorism



PROTECT

to strengthen our protection against a terrorist attack



PREPARE

to mitigate the impact of a terrorist attack

The CONTEST areas of Business will continue to be managed through the existing structures already in place in the County.

CONTEST



Provide strategic governance to the delivery of the Government CONTEST Strategy in Cumbria



Mitigate the risk from terrorism related activity within Cumbria and the wider threat to national security



Provide oversight for the delivery of the Cumbria Counter Terrorism Local Profile



Ensure the responsibility for the delivery of the four P's is led by the appropriate partner agency (Prevent, Protect, Prepare, Pursue)



Safer Cumbria Partnership Delivery Structure

To ensure the Safer Cumbria Partnership can deliver its three key functions it is has established the following business structure:

Safer Cumbria Partnership Board

Sets the VISION, PURPOSE and OUTCOMES that can be achieved as a partnership







Task & Finish Groups

Drive forward key pieces of work identified by the Groups above. They will run for a specific time period and address a particular area or accomplish a particular purpose

Priorities

The Safer Cumbria Partnership has consulted with wider Stakeholders to determine those key priority areas that require a dedicated input from the Partnership. Based on local and national sources (as outlined in Appendix B) such as the Cumbria Crime and Community Safety Strategic Assessment and the Cumbria Police Force Management Statement, the following priorities have been agreed.




The Criminal Justice, Contest and Community Safety Business Area Groups have developed dedicated delivery plans to address the issues relating to the priority areas along with implementing national initiatives and managing the day to day Criminal Justice, Contest and Community Safety business across Cumbria.

Although the priorities identified above form the key areas of focus for each of the Business Area Groups, they will also consider other areas of work including Modern Slavery, Hate Crime, Anti-Social Behaviour, Road Safety, the Criminal Justice System and provisions for Victims and Witnesses.

The Delivery Plans contain specific measurable actions that are monitored and evaluated to demonstrate successful completion, as detailed in the Safer Cumbria Accountability Framework (Appendix C). This is overseen by the Safer Cumbria Partnership Board.

The following diagram details the overarching outcomes, the Safer Cumbria Partnership Board aims to achieve to address each priority area.

Cumbria 2020 - 2025



INTRODUCTION

- 1.1 The Crime and Disorder Act 1998 (the "1998 Act") gives statutory responsibility to Local authorities, the police and key partners (Responsible Authorities) to reduce crime and disorder in their communities.
- 1.2 Later reviews and amendments of the 1998 Act in 2006 and 2011 included a need for annual strategic, assessment, public consultation and most recently in 2011 that Partnership Plans can be based on a term agreed by the CSP e.g. six monthly or yearly plans. (Collectively referred to in this document as the 1998 Act).
- 1.3 The main delivery vehicle to promote Community Safety in Cumbria is the Community Safety
 Business Area Group of Safer Cumbria in collaboration with the three Community Safety Partnerships
 within Cumbria all operating within District/Unitary Council boundaries. The vehicle to promote
 Criminal Justice in Cumbria is the Criminal Justice Business Area Group of Safer Cumbria.
- 1.4 For two tier authorities, such as Cumbria, a statutory Crime & Community Safety Agreement ("Agreement") has been introduced. The Safer Cumbria Partnership has identified the benefits of voluntarily entering this Agreement in order facilitate effective working across Cumbria on identified priorities.
- 1.5 The Safer Cumbria Partnership has identified those areas of work which can best be achieved by a collaborative multi agency approach. This agreement, along with the Safer Cumbria Strategy identifies the key priorities to address.



PURPOSE OF AGREEMENT

- 2.1 The purpose of this Agreement is to deliver the statutory duty under Section 17 of the 1998 Crime and Disorder Act stipulating that two tier authorities are required to prepare a Crime & Community Safety Agreement for the county. Section 17 recognises that there are key stakeholders that have responsibility for a wide range of services to the community that can deliver community safety solutions.
- 2.2 This Agreement is between the relevant Responsible Authorities and the wider Safer Cumbria Partner agencies including:

Responsible Authorities: Cumbria Police

Cumbria County Council Six District Councils

Cumbria & Lancashire CRC National Probation Service Cumbria Fire & Rescue Service

North Cumbria Clinical Commissioning Group Morecambe Bay Clinical Commissioning Group

Safer Cumbria Partners: Police & Crime Commissioner

Her Majesty's Courts & Tribunals Service

Crown Prosecution Service

NHS England

Her Majesty's Prison Service

Legal Aid Agency

- 2.3 This Agreement aims to develop a more joined-up approach to criminal justice and community safety service delivery, enable more effective and co-ordinated strategic planning across partner agencies and to ensure sustainable and lasting improvements in delivering outcomes.
- 2.4 This Agreement recognises that community safety issues do not always respect district boundaries, and that co-ordination of effort can lead to economies of scale, joined up working, and more effective outcomes. Accountability for delivery will remain with the Responsible Authorities, statutory Community Safety Partnerships and Safer Cumbria Partner Agencies.



COUNTY PRIORITIES

Priority issues have been identified through relevant strategic assessments. They identify issues which the Safer Cumbria Partnership consider to be both of high importance and would benefit from a countywide approach.

- 3.2 For Cumbria a number of crime and community safety issues have been identified as cross-cutting themes and are areas of work where the complexity or wider impact of those priority issues that suggest that a countywide approach would add value. These issues are:
- Domestic & Sexual Abuse
- Reducing Reoffending
- Serious Violence/Violent Crime
- Covid 19 Recovery & Stabilisation
- 3.3 The Safer Cumbria Partnership will review the progress of the delivery against these priority areas through its business structure, with any amendments made to the priorities based on a strategic needs assessment at least annually.



GOVERNANCE/DELIVERY FRAMEWORK

In order to deliver the Agreement an effective model of collective leadership and delivery is required. This is outlined in the terms of reference for the Safer Cumbria Partnership Board.

- 4.2 Several of the identified priorities already have existing multi-agency partnership arrangements in place that are ensuring a coordinated approach across organisations at a strategic level. This Agreement has built on these historic arrangements.
- 4.3 A Memorandum of Understanding is being developed with the other Strategic Boards across Cumbria to identify and monitor areas of cross overs between Boards and ensure there is no duplication of effort or conflicting workstreams.
- 4.4 Through the Safer Cumbria Business Area Groups which will be Chaired by Agency Representatives appointed by the Partnership, Delivery Plans will be produced to address delivery of the priority areas agreed by the Partnership.

DATA AND INFORMATION SHARING

5.1 Data and other crucial information is shared between agencies. This is done fully within the intent and authority provided by primary legislation and only for prescribed statutory functions aimed to research, prevent and tackle crime and disorder including the formation of crime and community safety strategies and at a local level problem solving groups.

AMENDMENT AND REVIEW

- 6.1 The Agreement may be amended by agreement of the Safer Cumbria Partnership Board.
- 6.2 The Safer Cumbria Partnership Board will review the Agreement annually.



Safer Cumbria

Accountability Framework



Background

The Safer Cumbria Partnership was formally established in December 2011 and has been regularly reviewed to ensure it is fit for function and purpose. The latest review took place during 2019/20, with a revised structure implemented to meet the developing needs of the county and national requirements. See Appendix C for the Safer Cumbria Partnership Structure.

The revised structure enables the Partnership to exercise its responsibilities and provide assurance that local and national priorities are delivered. To help facilitate this an Accountability Framework has been produced. This is underpinned by a reporting schedule and associated Delivery Plans.



Meeting Structure

The following arrangements provide a structure that is robust, open and transparent across all the partners agencies. Terms of reference are in place to support the functions of each of the Boards/Groups.

Delivery Plans

The Safer Cumbria Partnership Board determines the overarching strategic priority areas on an annual basis.

The Business Area Groups are responsible for developing a delivery plan to address the strategic priorities. This is produced annually and is approved by the Safer Cumbria Partnership Board. The Board then holds each of the Business Area Groups to account against these delivery plans mid and end of year (March & September) to identify the outcomes and associated impact of the work they have undertaken.

The delivery plans identify specific outcomes to measure the impact of successful completion of a piece of work. For example the outcomes may be the collation of either qualitative and quantitative performance measures or the completion of an end product.

However there are a set of national performance related indicators that the Safer Cumbria Board is required to measure as part of its key functions.



National Criminal Justice Performance

In line with national projects, the Safer Cumbria Partnership in its role as a Local Criminal Justice Board will submit local data/responses as and when requested.

As part of the Criminal Justice Business Area Group the Board will oversee local performance in relation to national targets through the work outlined in the Criminal Justice delivery plan.



Victims Code of Practice

The Safer Cumbria Partnership Board commissioned the development of a Quality Assessment Framework to measure compliance against the requirements outlined in the Victims Code of Practice.

The Board have agreed that this Quality Assessment Framework will be carried out annually and all criminal justice agencies will participate in the process, where relevant.


The Safer Cumbria Partnership Board has devolved responsibility for the continued development and undertaking of this process as well as addressing the issues and recommendations arising from the audit. This is reported back to the Board through the group delivery plan.



Domestic Homicide Reviews

The responsibility for conducting a Domestic Homicide Review statutory requirement sits with the District Community Safety Partnerships. As the Safer Cumbria Partnership fulfils the function of the County Strategy Group for Community Safety, it is the Board's responsibility to ensure the actions outlined from the Domestic Homicide Review Report are addressed and approved by the relevant parties.
