

PART 1 – ITEMS CONSIDERED IN THE PRESENCE OF THE PRESS AND PUBLIC

001. APOLOGIES FOR ABSENCE

There were no apologies for absence.

002. QUESTIONS FROM MEMBERS OF THE PUBLIC

No questions had been received in advance of the meeting from any members of the public.

003. URGENT BUSINESS AND EXCLUSION OF THE PRESS AND PUBLIC

There were no items of urgent business to be considered by the Committee.

004. DISCLOSURE OF PERSONAL INTERESTS

There were no disclosures of any personal interest relating to any item on the Agenda.



005. MINUTES

The Chair presented the minutes of the Public Accountability Conference held on the 16th July 2024 which had previously been circulated with the agenda. The minutes were agreed as an accurate record and signed by the Chair.

The Commissioner asked about the progress of the recruitment process to the Special Constabulary. DCC Martland will provide the Commissioner with an update in due course.

006. POLICING PERFORMANCE and OUTCOMES FOR VICTIMS

The presentation was given by the Director of Performance and Change.

999 call performance remains strong and has improved significantly since 2023. On average, 95% of 999 calls are answered within 10 seconds. The national KPI is 90% so Cumbria is sitting well above that. Nationally, Cumbria has been the top performing Force in the country & our position fluctuates between 1-6.

101 call performance is consistently high, and sitting not less than 95% of calls answered within 5 minutes. There is a consistent low abandonment rate of under 5%. It is worth noting that figures can be affected by one off anomalies such as a random caller making a lot of calls over a 4-5 hour period.

It has taken a combination of factors to get to this point including BCU Structure; Demand Analysis; Evaluation; Right people / Right place; 5% stretch target set by Chief Constable. All of these elements feed into the attrition rates. It has been a long journey over a period of time but shows a good grip with good processes and a consistently low abandonment rate.

The Commissioner had received good feedback from the recent engagement day, and is very reassured. The engagement day may be repeated in 2025.

Grade 1 response times are currently at 96% compared to 89.5% last year. Grade 2 response times are currently at 93.6% compared to 93.1% last year. This has been maintained throughout the summer.

Cyber Crime has seen a 21% increase on the year before (1,284 crimes captured / recorded with a cyber flag). The crime already exists.

Knife crime is a very specific category but has seen a reduction overall. Firearm down 14%.

Cumbria has very small numbers of crimes so any fluctuation has an effect on the percentage.

An increase has been seen in drugs offences and is as a result of pro-active work carried out by the Constabulary.

ASB is split into area and type of ASB. All areas except Barrow has seen a reduction in this area. The Commissioner is aware of the time and effort that has gone in to ASB as well as the work in the background to target hotspot areas. Visibility is a major factor, and clearly targeting hotspot areas is having a significant impact.

Going forward we would like to bolster what we have and try to obtain additional funding for this area.

The work is pre-planned to manage resource and demand, and shows the benefit of evidence based policing.

Op Enhance results so far are:

- 21% ASB reduction across the Force
- 37 ASB reduction in specific hotspots
- 15% reduction when the hotspot is excluded

The figures clearly show the benefits of targeting specific areas.

ACTION:

 Comms & Media team to do media around the ASB reductions. £1m funding with overlayed data and targeted areas have given an almost 40% reduction in ASB in hotspot areas.

Cumbria has the highest positive outcome rates nationally for VAWG. At the end of the FYD the figure was 19.9% compared to a current figure of 20.1%.

Other Forces are looking to Cumbria to see how the performance is being achieved.



Arson & Criminal Damage positive outcome rate has increased from 12.8% to 13.9% this FYD.

Burglary positive outcome rate has increased from 10.5% to 16.3%. Op Themis is targeting repeat offenders & pro-active work around prevention is taking place. There has been an 11.4% reduction in Burglary.

There has been re-classification around the most serious offences and a Det. Sup. In Op Themis is looking at investigations end to end.

ACTION:

Comms & Media to highlight the decrease in Burglary (11.4%)

Drugs has seen and increase of 29.4% in drug possession – this is a direct correlation with Stop & Search and is a good news story.

80% positive outcome rate last year compared to 75% currently – this is a slight reduction but is an improving picture overall.

Possession of Offensive Weapons – Positive outcome rate of 42% down from 44% last year. This figure fluctuates depending upon the type of offences.

There has been a recent change in the law in relation to Zombie knives, but there are not being found. The figures related to bladed articles or sharp objects.

Public Order Offences has seen an increase in positive outcome rates from 18.1% to 19.2%.

Robbery has low volume offences and has a positive outcome rate of 25.8%. Very small numbers in this category.

Rape has seen a decrease of 8.7% in the number of offences compared to last year.

The Online Safety Act means that every Force will have the same increase, so this category will increase nationally. The Chief Constable has commissioned and end to end deep dive into how we deal with rape in Cumbria – the results will come back to this group.

Theft has seen an increase of 19.3% (cost of living items such as food / nappies etc). Cumbria has seen the third lowest increase across the country and has a slower increase than the national rate.



Vehicle Offences – positive outcome rates are 12.1% which is an increase of 0.2pp on last year. There has been a slight seasonality increase over summer, but it is an improving picture.

Op. Lanterns and the ARIS funding into additional ANPR cameras is having an impact. ACC Blackwell was asked for detail around this and will feed back.

ACTION:

 ACC Blackwell to feed back the detailed impact of the additional ARIS funded ANPR cameras.

Violence Against the Person (includes VAWG) sees Cumbria with the fourth highest positive outcome rate nationally, so we are in a good position.

VAWG is a very broad category and has a Home Office definition of categories. It includes Domestic Abuse and Honour based crimes.

Discussions are taking place with CPS to re-introduce dedicated lawyers & re-instate early advice regarding charging decisions.

Rape cases in Cumbria is not where we would want it to be and work is on-going to understand this. It was noted that Cumbria does not have the backlog of cases that other areas have.

The Commissioner praised the consistent hard work in delivering and maintaining the continual improvement in performance. We need to keep the pressure on and are seeing the benefits – it is the right thing to do for the people of Cumbria. The Commissioner is very re-assured by what he has heard today and has no further questions.










Incident Response Grade 1 and 2

% of logs attended in target (with adjustment for regrading)



Positives

- **Residential burglary** volume has decreased significantly following increased governance, volumes have dropped by 91 when compared against the SPLY, (-19.12%).
- Residential burglary positive outcome rate has increased significantly and exceeds both the lower and upper KPIs.
- **All Crime volumes** are slightly up, by around ~5%. However, the positive outcome rate has increased by 1.16pp despite this increase
- **Victim based Crime** shows a similar trend, with an increase in volume of 5.61%, despite this the positive outcome rate has increased by 1.00pp.
- Robbery outcome rate has improved by 3.81pp, and the volume has decreased by ~24%.
- Domestic abuse positive outcome rates have increased by 1.42pp, despite the increase in volume










Crime Victim Satisfaction Overview












Domestic Abuse Crime Flag




Domestic Abuse Demographics









Domestic Abuse Use of Interventions







Crimes Recorded and Positive Outcome Rate for Drug Trafficking Offences







Suspected drugs related deaths








Cash and drugs seized by Roads Crime Unit





Communication & Media



The Constabulary communications team works to proactively demonstrate how the force tackles drugs misuse.

This is to promote confidence in the public that this issue is a priority for the force, that they can be reassured their information will be acted on – and to deter further offences.

The work falls broadly into two themes – enforcement and prevention of harm.





Enforcement



Enforcement

Press releases, social media and work with the media demonstrates the action taken to stop drugs crime.

This ranges from shining the spotlight on neighbourhood officers carrying out warrants, the work to stop serious and organised crime and work with other agencies.

The force highlights significant court case results to demonstrate the successful conclusion of cases and the fate for those carrying out these crimes.

National initiatives, such as work to prevent county lines drugs crime, are also promoted.

On Thursday 19 December, officers carried out three intel led warrants under the misuse of drugs act in Mirehouse, Whitehaven.

The warrants were conducted on Meadow Road, Latrigg Road and Derwentwater Road.

They were conducted by officers from intel, Neighbourhood Policing, Tactical Support, Roads Policing, Dog Unit, CID and Community Serious Organised Crime.

A 29-year-old man from Whitehaven on suspicion of being concerned in the supply Class A. He was released under investigation.

A 43-year-old man from Wigan was also arrested on A590 between Newby Bridge and Levens on suspicion of being concerned in the supply Class A and his vehicle uplifted. He was released under investigation.

A spokesperson from the forces intelligence unit said: "These warrants were only made possible by information provided from the community.

"We rely on the community to be our eyes and ears, so we can challenge the use and supply of drugs.

"We have contempt for the act of criminality, which has no place in our communities.

"If you suspect criminality is taking place in your neighbourhood then we want to hear from you so we can take action."

Prevention of harm



Equally as important is the work to prevent offences happening in the first place – and the work with agencies to prevent repeat offending.

This includes showcasing projects such as the 1CLIC partnership, which provides help to the people most in need, showing them that support is available. In the last year this has included work with media to promote positive case studies of the effect the work is having.

The Constabulary also promotes warn-and-inform messaging around the dangers of drugs and where help can be found.





Cumbria Police are warning the public of the of the dangers of buying prescription drugs online.

Prescription drugs falling into the bracket of benzodiazepines, which are known as benzos and include diazepam (sometimes referred to as Valium) and other prescription medication such as pregabalin, are suspected to have been a factor in reports such as overdoses and adverse effects in recent months.

Benzodiazepines are a group of sedative drugs that can be prescribed by suitably qualified health professionals, such as a GP, following a consultation undertaken with due care.

Some prescription drugs, such as pregabalin, are prescribed to treat anxiety, nerve pain and other health conditions. A NEW approach to tackling county lines has put Cumbria in a "great place" as Cumbria Police sees significant improvement on the situation.

County lines is the name used to refer to drug dealing where organised crime groups used phone lines to move and supply drugs, it often exploits vulnerable people by recruiting them to distribute the drugs.

The county - particularly the south - had "a significant problem" with this in 2020 and 2021.

However, a partnership between Cumbria Police and lived experience addiction support charity The Well Communities is helping to tackle the problem by taking a community based approach.

Det Sgt Kev Milby said: "County lines has a significant impact on all communities. It is in every single town and city in this country and obviously there's a lot of negative press that goes with it.

"We didn't have that wrap around approach as to how we could support the people that are most vulnerable to being exploited and the people that are in the midst of addiction.

"And that was the last part of the jigsaw that we put in place because we realised we can't arrest our way out of a problem."

'Disrupting' county lines

Cumbria Constabulary's Det Sgt Kevin Milby, the 1CLIC project manager, said the partnership allowed them to help "the people most in need" and show them that "support" was there.

"By disrupting those involved in county lines, we are preventing illegal drugs getting into our communities, which in turn prevents the associated detrimental impact drug supply has," he said.

For Liam, now 14 months "clean", he is looking forward to a "beautiful" future, free of drugs and drug dealers.




